4. RENTAL POLICIES

- Rental amount is required in full at time Rental Agreement is submitted and will be prepared once this Application is submitted and provided there is available supervision. Cash, Check, Visa, MasterCard or Discover accepted.
- If rental is to occur during Off-Peak Hours there will be an additional \$20 per hour added to the rental rate.
- A damage deposit in the amount of \$100 must accompany this form. Deposit will be returned to Rental Applicant at the end of the rental period if no damages have been incurred during the rental period.
- There is a half-hour minimum required for rental, except for the Theatre, which has a 5-hour minimum.
- There is a 48-hour cancellation policy. Reservations canceled with less than 48 hours’ notice will be charged full rental cost. For cancellations after entry into rental agreement, but more than 48 hours prior to Event, Rental Applicant shall be charged \$50 to compensate VPA for its administrative and lost opportunity costs.
- Attendees under the age of 18 must have adult supervision and must submit permission form from parents.
- Rental Applicant is financially responsible for any damage incurred during the rental period. Damage deposit is no limit on liability.
- VPA is not responsible for any: (i) loss or damage to equipment, materials or other property; (ii) personal injury or death; or (iii) any other loss or damage not directly caused by the wrongful intentional act of VPA.
