- 1. Program Price.** The program consists of private training as specified below. The training fee should be paid as specified on this form.
  - 2. Training.** Training provides individual coaching or instruction lessons designed to improve student's knowledge and capacity in performance. All lessons must be completed at a minimum of one per week beginning on the date of the contract.
  - 3. Refund/Expiration. ALL PAYMENTS ARE NON-REFUNDABLE.** There are no refunds or credit given for training sessions not used within the required period, which is between the start date and the expiration date of the program.
  - 4. Scheduling.** A set training schedule will be determined for the package prior to the first lesson. Student must sign the back of this form next to the corresponding date upon completion of each lesson in agreement that it was completed.
  - 5. Completion/Forfeiture Signatures.** Student must sign the back of this form next to the corresponding date upon completion of each lesson in agreement that it was completed.
  - 6. Cancellation Policy.** A session may be cancelled at least 24 hours prior to the time it was originally scheduled. The session may then be rescheduled for no additional charge. In the event a session is cancelled less than 24 hours in advance, the session will be considered forfeiture.
  - 7. Tardiness.** If a client plans on being delayed beyond 10 minutes they must notify the instructor at least 24 hours in advance and reschedule the session for no additional charge. If 24 hours notice is not given the session will be considered forfeiture.
  - 8. No Shows.** If a client is over 10 minutes delayed and/or not present at a session without notifying the instructor at least 24 hours in advance, the neglected lesson will be considered forfeiture.
  - 9. Rescheduling.** Rescheduling is possible for any client who cancels a scheduled session at least 24 hours in advance. There will be no additional charge for a rescheduled session in a case such as this. In the event that a rescheduled session is desired due to a cancellation less than 24 hours in advance, a client being delayed for a lesson for more than 10 minutes, or a no show, rescheduling a session is possible for an additionally charged individual lesson.
  - 10. Waiver and Release.** You (buyer, parent, spouse or guest [as applicable]) agree that if you engage in any activity, you do so at your own risk. This includes, without limitation, your receipt of training, used of any equipment and your participation in any activity or instruction now or in the future made available at Virtuoso Performing Arts, LLC. You agree that you are voluntarily participating in these activities and assuming all risk of injury or contraction of any illness or medical condition that might result there from or any damage of any personal property.
